



EXECUTIVE ORDER NO. 10

“CREATION OF THE MUNICIPAL INTER- AGENCY TASK FORCE (IMTF) FOR THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC)”

WHEREAS, DILG Memorandum Circular No. 2021-039 dated April 07, 2021 entitled “Guidelines for the Establishment, Strengthening and Monitoring of Local Council for the Protection of Children (LCPC) at all Levels and for Other Purposes” provides for the creation of the Inter-Agency Monitoring Task Force (IMTF) in the levels of City/Municipality/Province/HUC, and Region to monitor and evaluate the functionality of Local Council for the Protection of Children;

WHEREAS, the said circular also provides for the duties and functions of the Inter-Agency Monitoring Task Force (IMTF) and criteria for assessment to determine the functionality of LCPC;

NOW, THEREFORE, I, HARRY D. FLORIDA, Municipal Mayor of Allacapan, Cagayan, by virtue of the powers vested in me by law, **THE INTER-AGENCY MONITORING TASK FORCE (IMTF) FOR THE LOCAL COUNCIL FOR THE PROTECTION OF CHILDREN (LCPC)** in the municipality of Allacapan is hereby organized to be composed of the following:

SECTION 1. Creation of the Inter- Agency Monitoring Task Force (IMTF). The IMTF shall have the following members:

SECTION 2. Duties and Functions of the Municipal Inter- Agency Monitoring Task Force. The Inter-Agency Monitoring Task Force shall have the following functions:

1. Gather, collect and organize the required documents from the Barangay Council for the Protection of Children (BCPC) on or before February 15 of the assessment year;
2. Evaluate and assess the BCPC based on the documents submitted;

3. Meet with concerned barangay officials for feedback giving on the strengths or weaknesses of BCPC; and
4. Submit required reports to concerned agencies using the prescribed forms;
5. Other functions as may be prescribed by law.

SECTION 3. Meetings. the IMTF shall convene during the assessment of the BCPC Functionality and submit all required documents on or before the scheduled deadline.

SECTION 4. Repealing Clause. All prior executive orders and other issuances on the organization and functions of the Municipal Council for the Protection of Children in the Municipality of Allacapan inconsistent herewith shall be deemed superseded and hereby repealed.

SECTION 5. Effectivity. This Executive Order shall take effect immediately.
