Section 2- FUNCTIONS: The reorganized Municipal Anti- Drug Abuse Council shall have the following functions:

1. Serve as focal point through which the various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for coordination of existing services and programs and those which might be developed in the future;
3. Provide for a mechanism to obtain funds, volunteers, facilities and technical expertise; and
4. Perform other related responsibilities as may be assigned by competent authorities.

This Executive Order shall take effect immediately.

Section 3- MEETINGS: The Municipal Anti- Drug Abuse Council shall meet as often as may be necessary.

Section 4- EFFECTIVITY: This Executive order shall take effect immediately.
